Case of Essentiality Certificate under rule 44 of Delhi  
School Education Act, 1973.

- 1. In reference to your application on the subject cited above directed to convey the permission of the Director of Education, Delhi to your society to establish a new school class Ist to VIII (without aid) in Lohi Road Complex Area Distt South, Subject to the following conditions:-
- 2. The provision of DSEA/R, 1973 and the rules framed there- will be observed by the society.
- 3. The management of the school will fulfil all the conditions under rule 50 and will provide all the facilities given in DSEA, 1973 to the instt.
- 4. The management of the school will get the schem of manag- approved from the department immediately.
- 5. Only qualified and trained teachers will of appointed Govt. alongwith all allowances will be paid to the teaching and staff through crossed cheque.
- 6. The management of the school will not ask for grant-in-aid from the department.
- 7. The school will not run for the profit of any individual or group of persons.
- 8. In case at any time the management of the school is unable to pay the school moveable and non-moveable property of the school transferred in the name of Director of Education, Delhi.
- 9. The recognised classes shall be run at one place only.
- 10. The management of the school will apply for grant of recog- nition of the school under DSEA/R, 1973 and recognition will not be granted unless statutory provisions as section 4(I)(a) to (f) and rules 50 & 51 are fulfilled.


That the school shall be run under the control of Kishan & Sons Charitable Trust (Regd.), Delhi and suitable land will be made available for the construction of suitable building on the land allotted to the society, as declared as per the specifications of the deptt. with a period of three years.

That the management of the school will obtain land from DDA in the name of the society through Directorate of Education, Delhi and construct a school building thereon for the proposed school as per specification of the deptt.

That adequate and sufficient accommodation of 12sq.ft. per student shall be provided for class-room. The normal size of class-room will be 24'X20'. No other activities other than school shall be run.


Recognition for the proposed school is not sought after all the above conditions within a period of three years, this permission to run a new school shall be treated as cancelled.
